- Makes basic occupational calculations of building elements.
- Draws basic geometrical shapes, projection and outlook of object, perspective and cross sections.
- Assembles wooden penthouse, free standing and suspensory roof, eaves, collectors and downpipes.
- Draws details of wooden penthouse, free standing, suspensory roof details and roof isolation.
- Makes joints of concrete roof, concrete roof formwork, concreting, steel roof puncheons, bolt and welding.
- Makes veneering, heat insulation and water sealing on roofs.
- Draws building projects and building settlement by taking relievo measure.
- Calculates building costs, excavation quantity, budget estimate, progress payment and makes approvals.
