- get the necessary information for assessment/interpretation from the child's family
- observe the child's attitude, behavior and uses words when she/he is drawing
- take note the necessary points
- support the child to continue when she/he resists and hesitates
- make reporting about the process

4. Range of occupations accessible to the holder of the certificate (1)

- They can interpret child's drawings while working on child at special education centers, kindergartens and nurseries, private counseling centers, and hospitals.
